The company is engaged in uranium mining, conversion-enrichment, spent fuel recycling, nuclear logistics, dismantling, and nuclear cycle engineering activities. in Châtillon, Hauts-de-Seine. Orano is majority owned by the French state. It was created in 2017 as a result of restructuring and recapitalizing of the nuclear conglomerate Areva. France was a long-standing commercial partner of Iraq, having taken part in the Turkish Petroleum Company as early as 1924. In the 1970s, Iraq supplied 24 percent of France's oil, and France was still struggling to sell goods, including weapons, to offset its commercial imbalance with such solvent countries. France traditionally had a balanced policy in the Middle East, and wanted to continue those both for general reasons of state, as well as ensuring petroleum supply. More generally, the French have been present in the Middle East for centuries until the 20th century, as witnessed by the Sykes–Picot and San Remo

agreements. As of 2019, the Iran-EU trade relations are stained due to the sanctions re-imposed on Iran by the United States after the US unilateral withdrawal from the multinational Joint Comprehensive Plan of Action agreement. The EU has, however, established a special Instrument in Support of Trade Exchanges to enable EU-Iran trade bypassing the US sanctions. In fact, the EU were seen to be "urging Chinese and Russian counterparts to do more to support bilateral economic ties with Iran". Nonetheless, the European Union...

History of the nuclear program of Iran S. Atoms for Peace initiative. Iraq's use of chemical weapons during that war influenced Iran's post-revolution leaders to secretly revive a weapons-related nuclear program in the mid-1980s. Construction of the Bushehr 1000 MWe power reactor resumed with Russian help and was completed in 2011 under IAEA safeguards. 67% U-235, shrinking Iran's enriched uranium stockpile to 300 kg, and Iran's nuclear program began under Shah Mohammad Reza Pahlavi in the 1950s as part of the U. During the 1970s, Iran pursued ambitious plans for up to 20 nuclear power plants (starting the Bushehr reactors with German assistance), but progress halted after

the 1979 Islamic Revolution and the Iran-Iraq War. By the 1990s, Iran was rebuilding its nuclear infrastructure: it sought a nuclear fuel cycle (mining, conversion, enrichment) and covertly obtained centrifuge designs from the Pakistani Abdul Qadeer Khan network. imposed strict limits on Iran's nuclear program, capping uranium enrichment at 3.5% -supplied 5 MW research reactor. In 1967, Iran established the Tehran Nuclear Research Center with a U.S.

Megatons to Megawatts Program Under this Agreement, Russia agreed to supply the United States with low-enriched uranium (LEU) obtained from high-enriched uranium (HEU) found to be in excess of Russian defense purposes. The official name of the program is the "Agreement between the Government of the Russian Federation and the Government of the United States of America Concerning the Disposition

of Highly-Enriched Uranium Extracted from Nuclear Weapons", dated February 18, 1993. to Megawatts Program, also called the United States-Russia Highly Enriched Uranium Purchase Agreement, was an agreement between Russia and the United States whereby Russia converted 500 metric tons of "excess" weapons-grade uranium (enough for 20,000 warheads) into 15,000 metric tons of low enriched uranium, which was purchased by the US for use in its commercial nuclear power plants e59da8a37d

Development of nuclear technology began in the Pahlavi era and continued after the 1979 Iranian Revolution. The United States Intelligence Community assessed in 2007 that Iran pursued nuclear weapons under the AMAD Project between the late 1980s until 2003, then ceasing its effort. In 2005, the IAEA Board of Governors found Iran in non-compliance with its NPT safeguards agreement and in 2006 the United Nations Security Council... e59da8a37d Iran's nuclear activities remained mostly clandestine until 2002, when dissidents revealed undeclared facilities at Natanz (uranium enrichment) and Arak (heavy water reactor). This

sparked an international crisis. Under pressure, Iran agreed in late 2003 to suspend... By 2005, China supplied 8.3% of Iran's total imports, ranking as the second-largest exporter after Germany. Between 2000 and 2005, Iran's imports from China surged by 360%, with China accounting for 9.5% of Iran's total imports. According to Middle East Policy this rapid expansion was attributed to China's economic...

China-Iran trade relations Chinese investments span multiple sectors, including infrastructure, transportation, energy, and defense, and also Iran's nuclear program. As Iran's largest trading partner, China conducts billions of dollars in bilateral trade annually, primarily through Iranian oil exports and Chinese manufactured goods. Despite international sanctions, China has sustained economic engagement with Iran, often employing alternative financial mechanisms to bypass restrictions. a key partner in Iran's nuclear development. It assisted in building research reactors, supplied uranium hexafluoride for enrichment, and helped construct China-Iran trade relations have expanded in recent years, driven by economic, energy, and strategic cooperation

Iran-European Union relations Trade with Iran is subject to the general EU import regime and the EU supports the goal of Iranian accession to the World Trade Organization (WTO). The EU is Iran's largest trading partner, along with China and the United Arab Emirates. Additionally, Iran is required to dilute existing enriched Uranium stockpiles to a concentration of 20%. between the US and the Islamic Republic. The EU has accused and criticised Iran for human rights violations, which led to diplomatic tensions, but both sides aim at improving and normalising relations. While the economic European Union-Iran relations are the bilateral relations between Iran and the European Union (EU). Should Armenia, which is

planning to apply for EU membership, and Turkey, which is a candidate for EU membership, accede to the EU, Iran will be a border neighbor with the European Union e59da8a37d

The agreement is based on the 24 November 2013 Geneva interim framework agreement, officially titled the Joint Plan of Action (JPA). The Geneva agreement was an interim deal, in which Iran agreed to roll back parts of its nuclear program in exchange for relief from some sanctions and that went into effect on 20 January 2014. The first American sanctions were imposed in November 1979 after radical students seized the United States Embassy in Tehran. Although lifted in 1981, they were reimposed in 1987 and progressively expanded through successive US executive orders and legislation. The United Nations Security Council imposed multilateral sanctions beginning in December 2006 under United Nations Security Council Resolution 1737, after Iran refused to halt its uranium enrichment programme. The Joint Comprehensive Plan of Action (JCPOA) of 2015 led to the lifting of most UN and multilateral sanctions in exchange... e59da8a37d
