India administered Jammu and Kashmir as a state from 17 November 1952 to 31 October 2019. Article 370 conferred on it the power to have a separate constitution, a state flag, and autonomy of internal administration. Among the Indian government actions accompanying the revocation was the cutting off of communication lines in the Kashmir Valley which was restored after 5 months. Thousands of additional security forces were deployed to curb any uprising. Several leading Kashmiri politicians were taken into custody, including the former chief minister. Government officials described these restrictions as designed for preempting violence, and justified the revocation for enabling people of the state to access government programmes such as reservation, right to education and right to information.

This papyrus was discovered by Grenfell and Hunt in 1897 in Oxyrhynchus. The text was published by Grenfell and Hunt in 1899. The fragment is used by palaeographers and papyrologists for dating ancient documents, which do not have dates added by their scribes. Young Kyu Kim used it to date biblical manuscript Papyrus 46 to the end of the 1st century. After the state constituent assembly was convened, it recommended the provisions of the Indian constitution that should apply to the state, based on which 1954 Presidential Order was issued. Since the state constituent assembly dissolved itself without recommending the abrogation of Article... The measurements of the fragment are 175 by 97 mm. The document is mutilated. Article 370 was drafted in Part XXI of the Indian constitution titled "Temporary, Transitional and Special Provisions". It stated that the Constituent Assembly of Jammu and Kashmir would be empowered to recommend the extent to which the Indian constitution would apply to the state. The state assembly could also abrogate Article 370 altogether, in which case all of the Indian Constitution would have applied to the state. Proponents of the IIRAIRA

contend the law was necessary to end loopholes present beforehand in US immigration policy, which undermined the immigration system. A major motivator behind IIRAIRA was to deter further illegal immigration into the US, but the success in achieving this has been mixed, with both an increase in deportation since IIRAIRA was enacted in 1996, from around 50,000...

dd625dddfc Former United States President Bill Clinton asserted that the legislation strengthened "the rule of law by cracking down on illegal immigration at the border, in the workplace, and in the criminal justice system—without punishing those living in the United States legally". However, IIRAIRA has been criticized as overly punitive and intensifying border militarization. With IIRAIRA, all aliens, regardless of legal status, were liable to removal and it expanded types of transgressions that could lead to removal. dd625dddfc The Indian Removal Act of 1830, the key law which authorized the removal of Native tribes, was signed into law by United States president Andrew Jackson on May 28, 1830. Although Jackson took a hard line on Indian removal, the law was primarily enforced during the Martin Van Buren administration, 1837 to 1841. After the enactment of the Act, approximately 60,000 members of the Cherokee, Muscogee (Creek), Seminole, Chickasaw, and Choctaw nations (including thousands of their black slaves) were forcibly removed from their

Article One of the United States Constitution Under Article One, Congress is a bicameral legislature consisting of the House of Representatives and the Senate. Under Article Article One of the Constitution of the United States establishes the legislative branch of the federal government, the United States Congress. Article One also establishes the procedures for passing a bill and places limits on the powers of Congress and the states from abusing their powers. Article One grants Congress enumerated powers and the ability to pass laws "necessary and proper" to carry out those powers.
