PDSs are often found at the boundaries of a system, where information is being moved to and from other systems or persistent storage and the problem domain logic that is found in other parts of the system is irrelevant. For example, PDS would be convenient for representing the field values of objects that are being constructed from external data, in a part of the system where the semantic checks and interpretations needed for valid objects are not applied yet. Its initial purpose was to construct utilities running on Unix, and was later applied to re-implementing the kernel of the Unix operating system. During the 1980s, C gradually gained popularity, leading to it becoming one of the most widely used programming languages, with C compilers available for practically all modern computer architectures and operating systems. The book *The C Programming Language*, co-authored by the original language designer, served for many years as the de facto standard for the language.
