called a polytope. The shape of this polytope is defined by the constraints applied to the objective function.

One means of accomplishing this involves splitting images into tiles that are processed independently. However, regions that straddle a tile border might be split up or lost if the fragments do not meet the segmentation algorithm's minimum size requirements. A trivial workaround involves overlapping tiles, i.e. allowing each processor to consider additional pixels around its tile's border. Unfortunately this increases the computational load, since the processors on both sides of a tile boundary are performing redundant work. Also, only objects smaller than the tile overlap are guaranteed to be preserved, which means that long objects such as rivers in aerial imagery are still likely to be split.
