Sampling (statistics) Probability sampling includes: simple random sampling, systematic sampling, stratified sampling, In statistics, quality assurance, and survey methodology, sampling is the selection of a subset of individuals from within a statistical population to estimate characteristics of the whole population. The purpose of sampling is to reduce the cost and/or the amount of work that it would take to survey the entire target population. A survey that measures the entire target population is called a census. In SRS, each subset of k individuals has the same probability of being chosen for the sample as any other subset of k individuals. The principle of simple random sampling is that every set with the same number of items has the same probability of being chosen. For example, suppose 10 college students want a ticket for a basketball game, but there are only six tickets available to them, so they decide to have a fair way to see who gets to go. Then, everybody is given a number in the range from 1 to 10, and random numbers are generated, either electronically or from a table of random numbers. Numbers outside the range from 1 to 10 are ignored, as are any numbers previously selected. The first six numbers would identify the lucky ticket winners. Nonprobability samples are not intended to be used to infer from the sample to the general population in statistical terms. In cases where external validity is not of critical importance to the study's goals or purpose, researchers might prefer to use nonprobability sampling. Researchers may seek to use iterative nonprobability sampling for theoretical purposes, where analytical generalization is considered over statistical generalization. The sampling distribution of a statistic is the distribution of that statistic, considered as a random variable, when derived from a random sample of size The population within a cluster should ideally be as heterogeneous as possible, but there should be homogeneity between clusters. Sampling has lower costs and faster data collection compared to a census recording data from the entire population (in many cases, collecting the whole population is impossible, like getting sizes of all stars in the universe). Acceptance sampling is used to... == Cluster elemental == While probabilistic methods are suitable for large-scale studies concerned with representativeness, nonprobability approaches may be more suitable for in-depth qualitative research in which the focus is often to understand complex social phenomena. The in-depth analysis of a small purposive sample or case study enables the discovery and identification of patterns and causal mechanisms that do not draw time and context-free assumptions. Another advantage of nonprobability sampling is its lower cost compared to probability sampling.

Sample space The elements of a sample space may be numbers, words, letters, or symbols. A sample space is usually denoted using set notation, and the possible ordered outcomes, or sample points, are listed as elements in the set. It is common to refer to a sample space by the labels S , Ω , or U (for "universal set"). They can also be finite, countably infinite, or uncountably infinite. In probability theory, the sample space (also called sample description space, possibility space, or outcome space) of an experiment or random trial is the set of all possible outcomes or results of that experiment.

Survey samples can be broadly divided into two types: probability samples and super samples. Probability-based samples implement a sampling plan with specified probabilities (perhaps adapted probabilities specified by an adaptive procedure). Probability-based sampling allows design-based inference about the target population. The inferences are based on a known objective probability distribution that was specified in the study protocol.... Stratification is the process of dividing members of the population into homogeneous subgroups before sampling. The strata should define a partition of the population. That is, it should be collectively exhaustive and mutually exclusive: every element in the population must be assigned to one and only one stratum. Then sampling is done in each stratum, for example: by simple random sampling. The objective is to improve the precision of the sample by reducing sampling error. It can produce a weighted mean that has less variability than the arithmetic mean of a simple random sample of the population.

Sampling bias sampling bias is a bias in which a sample is collected in such a way that some members of the intended population have a lower or higher sampling probability than others. In statistics, sampling bias is a bias in which a sample is collected in such a way that some members of the intended population have a lower or higher sampling probability than others. If this is not accounted for, results can be erroneously attributed to the phenomenon under study rather than to the method of sampling. It results in a biased sample of a population (or non-human factors) in which all individuals, or instances, were not equally likely to have been selected.

Sampling distributions are important in statistics because they provide a major simplification en route to statistical inference. More specifically, they allow analytical considerations to be based on the probability distribution of a statistic, rather than on the joint probability distribution of all the individual sample values.

A distinction, albeit not universally accepted, of sampling bias is that it undermines the external validity of a test (the ability of its results to be generalized to the entire population), while selection bias mainly addresses internal validity for differences or similarities found in the sample at hand. Systematic sampling However, it is not the same as SRS because not every possible sample of a certain In survey methodology, one-dimensional systematic sampling is a statistical method involving the selection of elements from an ordered sampling frame. When a geographic area is sampled for a spatial analysis, bi-dimensional systematic sampling on an area sampling frame can be applied. The most common form of systematic sampling is equal probability sampling (also known as epsem), an equiprobability method. This applies in particular when the sampled units are individuals, households or corporations. systematic sampling functionally similar to simple random sampling (SRS)

In statistical surveys, when subpopulations within an overall population vary, it could be advantageous to sample each subpopulation (stratum) independently.

Cluster sampling It is often used in marketing research. In this sampling plan, the total population is divided into these groups (known as clusters) and a simple random sample of the groups is selected In statistics, cluster sampling is a sampling plan used when mutually homogeneous yet internally heterogeneous groupings are evident in a statistical population.

In this sampling plan, the total population is divided into these groups (known as clusters) and a simple random sample of the groups is selected. The elements in each cluster are then sampled. If all elements in each sampled cluster are sampled, then this is referred to as a "one-stage" cluster sampling plan. If a simple random subsample of elements is selected within each of these groups, this is referred to as a "two-

stage" cluster sampling plan. A common motivation for cluster sampling is to reduce the total number of interviews and costs given the desired accuracy. For a fixed sample size, the expected random error is smaller when most of the variation in the population is present internally within the groups, and not between the groups. b0ba942ffa Sampling bias is usually classified as a subtype of selection bias, sometimes specifically termed sample selection bias, but some classify it as a separate type of bias. b0ba942ffa
