== History == The Global Mobile Commerce Forum, which came to include over 100 organisations, had its fully minuted launch in London on 10 November 1997. Kevin Duffey was elected Executive Chairman at the first meeting in November 1997. The meeting was opened by Dr Mike Short, former chairman of the GSM Association, with the very first forecasts for mobile commerce from Kevin Duffey (Group Telecoms Director of Logica) and Tom Alexander (later CEO of Virgin Mobile and then of Orange). Over 100 companies joined the Forum within a year, a number of them forming mobile commerce teams of their own, e.g. MasterCard and Motorola. Among these one hundred companies, the first two were Logica and Cellnet (which later became O2). Dormant Commerce Clause The primary focus of the doctrine is barring state protectionism. If the statute is discriminatory, the state has the burden to justify both the local benefits flowing from the statute and to show the state has no other means of advancing the legitimate local purpose. The dormant Commerce Clause is used to prohibit state legislation that discriminates against, or unduly burdens, interstate or international commerce. history of commerce clause jurisprudence evidences a distinct difference in approach where the state is seeking to exercise its public health and safety powers The dormant Commerce Clause, or negative Commerce Clause, in American constitutional law, is a legal doctrine that courts in the United States have inferred from the Commerce Clause in Article I of the US Constitution. Courts first determine whether a state regulation discriminates on its face against interstate commerce or whether it has the purpose or effect of discriminating against interstate commerce 3f3c67db0c

Traditional markets in Mexico These tianguis markets remain in Mexico, with the most traditional held on certain days, put up and taken down the same day, much the way it was done in Mesoamerica. This market developed in Mexico as a way to regulate pre-Hispanic markets called tianguis. These markets are distinct from others in that they are almost always housed in buildings owned and operated by the local government, with numerous stands inside rented by individual merchants, who usually sell produce and other basic food staples. They go by a variety of names such as "mercados públicos" (public markets), "mercados municipales" (municipal markets) or even more often simply "mercados" (markets). Consequently, it significantly impacts economic development by boosting productivity and creating more job opportunities.
