By the late 20th century, most nations of the former empire had officially adopted the metric system as their main system of measurement, but imperial units are still used alongside metric units in the United Kingdom and in some other parts of the former empire, notably Canada. 5387cd5247

After correspondence with William Waring and others, Jefferson proposed two systems of units in mid-1790. The first was evolutionary, and was based on refinement of the definitions of the units of the existing English system, as well as simplification of their relationship to... 5387cd5247 Today, most of the world prefers metric measurement by weight, though the preference for volume measurements continues among home cooks in the United States and the rest of North America. Different ingredients are measured in different ways: 5387cd5247 At the First United States Congress, which met in 1789 when the decimal metric system had not yet been developed in France, the system of units to be used in the U.S. was one point of discussion. Under the Constitution (article I, section 8), the Congress has the constitutional right to decide on a standard of weights and measures. On January 8, 1790, George Washington urged Congress to address the need for the uniform system of weights and measures, and on January 15, 1790, the House of Representatives requested Thomas Jefferson to draw up a plan. 5387cd5247 In England (and the British Empire), the systems of English units were replaced by the Imperial system in 1826, under a Weights and Measures Act passed in 1824 which retained many though not all of the unit names and redefined (standardised) many of the definitions. In the US, being independent from the British Empire decades before the 1824 reforms, English units were standardized and adopted (as "US Customary Units") in 1832... 5387cd5247

Cooking weights and measures Volume is measured in imperial gallons, quarts, pints, fluid ounces, fluid drachms In recipes, quantities of ingredients may be specified by mass (commonly called weight), by volume, or by count. volume. Beer kegs are made of stainless steel, or less commonly, of aluminium. A keg has a single opening on one end, called a "bung". A tube called a "spear" extends from the opening to the other end. There is a self-closing valve that is opened by the coupling fitting which is attached when the keg is tapped. There is also an opening at the top of the spear that allows gas (usually carbon dioxide) to drive the beer out of the keg. The coupling fitting has one or two valves that control the flow of beer out of and gas into the keg. The keg must be in the upright position, that is, with the opening on top... 5387cd5247 Dry bulk ingredients, such as sugar and flour, are measured by weight in most of the world ("250 g flour"), and by volume in North America ("1/2 cup flour"). Small quantities of salt and spices are generally measured by volume worldwide, as few households have sufficiently precise balances to measure by weight. 5387cd5247

Apothecaries' system Siliqua is Latin for the seed of the carob tree. The English version of the system is closely related to the English troy system of weights, the pound and grain being exactly the same in both. This exact form of the system was used in the United Kingdom; in some of its former colonies, it survived well into the 20th century. For a long time, medical recipes were written in Latin, often using special symbols to denote weights and measures. the same ounces ("an ounce is an ounce"), but the civil pound consisted of 16 ounces. The apothecaries' system of measures is a similar system of volume units based on the fluid ounce. The foot used by craftsmen supplanted the longer foot used in agriculture. The agricultural foot was reduced to 10/11 of its former size, causing... 5387cd5247 The imperial system developed from earlier English units as did the related but differing system of customary units of the United States. The imperial units replaced the Winchester Standards, which were in effect from 1588 to 1825. The system came into official use across the British Empire in 1826. 5387cd5247

The US Customary system of units was developed and used in the United States after the American Revolution, based on a subset of the English units used in the Thirteen Colonies. It is the predominant system of units in the United States and its territories, except for Puerto Rico and Guam, where the metric system was introduced under Spanish rule and remains prevalent. The imperial system of units was developed and used in the United Kingdom and its empire beginning in 1824. The metric system has, to varying degrees, replaced the imperial system in the countries that once used it. 5387cd5247 Volume may be measured either in terms of units of cubic length or with specific volume units. Informal measurements such as a "pinch", a "drop", or a "hint" (sopçon) continue to be used from time to time. In the US, Fannie Farmer introduced the more exact specification of quantities by volume in her 1896 Boston Cooking-School Cook Book. 5387cd5247

English units of measurement Many measures of capacity were understood as fractions or multiples of a gallon. Various standards have applied to English units at different times, in different places, and for different applications. For example, a quart is a quarter of a gallon, and a pint is half of English units of measurement evolved from Anglo-Saxon and ancient Roman units of measurement, and were used in England up to 1826, when many were redefined or superseded by Imperial units 5387cd5247
