== Implementation == a489ef542a Use of the term "English units" can be ambiguous, as, in addition to the

meaning used in this article, it is sometimes used to refer to the units of the descendant Imperial system as well to those of the descendant system of United States customary units.

In England (and the British Empire), the systems of English units were replaced by the Imperial system in 1826, under a Weights and Measures Act passed in 1824 which retained many though not all of the unit names and redefined (standardised) many of the definitions. In the US, being independent from the British Empire decades before the 1824 reforms, English units were standardized and adopted (as "US Customary Units") in 1832...

The Weights and Measures Act 1824 was initially scheduled to go into effect on 1 May 1825. The Weights and Measures Act 1825 pushed back the date to 1 January 1826.

Dry bulk ingredients, such as sugar and flour, are measured by weight in most of the world ("250 g flour"), and by volume in North America ("1/2 cup flour"). Small quantities of salt and spices are generally measured by volume worldwide, as few households have sufficiently precise balances to measure

Cooking weights and measures S. Weight is measured in ounces and pounds (avoirdupois) as in the U. volume. Volume is measured in imperial gallons, quarts, pints, fluid ounces, fluid drachms In recipes, quantities of ingredients may be specified by mass (commonly called weight), by volume, or by count a489ef542a

By the late 20th century, most nations of the former empire had officially adopted the metric system as their main system of measurement, but imperial units are still used alongside metric units in the United Kingdom and in some other parts of the former empire, notably Canada. a489ef542a Beer kegs are made of stainless steel, or less commonly, of aluminium. A keg has a single opening on one end, called a "bung". A tube called a "spear" extends from the opening to the other end. There is a self-closing valve that is opened by the coupling fitting which is attached when the keg is tapped. There is also an opening at the top of the spear that allows gas (usually carbon

dioxide) to drive the beer out of the keg. The coupling fitting has one or two valves that control the flow of beer out of and gas into the keg. The keg must be in the upright position, that is, with the opening on top... a489ef542a

The imperial system developed from earlier English units as did the related but differing system of customary units of the United States. The imperial units replaced the Winchester Standards, which were in effect from 1588 to 1825. The system came into official use across the British Empire in 1826. a489ef542a In most... a489ef542a The modern UK

legislation defining the imperial system of units is given in the Weights and Measures Act 1985 (as amended).

Most of the units of measure have been adapted in one way or another since the Norman Conquest (1066). The units of linear measure have changed the least – the yard (which replaced the ell) and the chain were measures derived in England. The foot used by craftsmen supplanted the longer foot used in agriculture. The agricultural foot was reduced to 10/11 of its former size, causing...

The US customary system has a set of units for fluids, it has a different measure for dry goods for the pint, quart and barrel, and a peck and bushel for dry goods only. The imperial system has only one set of measurements, defined independently of the US customary system.

The decimal dollar had already been agreed upon in principle in 1785, but would not be implemented until after the enactment of the Coinage Act of 1792. After correspondence with William Waring and others, Jefferson proposed two systems of units in

mid-1790. The first was evolutionary, and was based on refinement of the definitions of the units of the existing English system, as well as simplification of their relationship to...

The use of different measure and weight systems depending on the purpose was an almost universal phenomenon in Europe between the decline of the Roman Empire and metrication. This was connected with international commerce, especially with the need to use the standards of the target market and to compensate for a common weighing practice that caused a difference between actual and...

The two main sets of English units were the Winchester Units, used from 1495 to 1587, as affirmed by King Henry VII, and the Exchequer Standards, in use from 1588 to 1825, as defined by Queen Elizabeth I.

Today, most of the world prefers metric measurement by weight, though the preference for volume measurements continues among home cooks in the United States and the rest of North America. Different ingredients

are measured in different ways:

The US Customary system of units was developed and used in the United States after the American Revolution, based on a subset of the English units used in the Thirteen Colonies. It is the predominant system of units in the United States and its territories, except for Puerto Rico and Guam, where the metric system was introduced under Spanish rule and remains prevalent. The imperial system of units was developed and used in the United Kingdom and its empire beginning in 1824. The metric system has, to varying degrees, replaced the imperial system in the countries that once used it.

For most of history, most cookbooks did not specify quantities precisely, instead talking of "a nice leg of spring lamb", a "cupful" of lentils, a piece of butter "the size of a small apricot", and "sufficient" salt. Informal measurements such as a "pinch", a "drop", or a "hint" (soupçon) continue to be used from time to time. In the US, Fannie Farmer introduced the more exact specification of quantities by volume in her 1896 Boston Cooking-School Cook Book. a489ef542a

Apothecaries' system It divides a pound into 12 ounces, an ounce into 8 drachms, and a drachm into 3 scruples of 20 grains each. For a long time, medical recipes were written in Latin, often using special symbols to denote weights and measures. Siliqua is Latin for the seed of the carob tree. This exact form of the system was used in the United Kingdom; in some of its former colonies, it survived well into the 20th century. the same ounces ("an

At the First United States Congress, which met in 1789 when the decimal metric system had not yet been developed in France, the system of units to be used in the U.S. was one point of discussion. Under the Constitution (article I, section 8), the Congress has the constitutional right to decide on a standard of weights and measures. On January 8, 1790, George Washington urged Congress to address the need for the uniform system of weights and measures, and on January 15, 1790, the House of Representatives requested Thomas Jefferson to draw up a plan. a489ef542a Volume may be measured either in terms of units of cubic length or with specific volume units. The units of cubic length (the cubic inch, cubic foot, cubic mile, etc.) are the same in the imperial and US customary systems, but they differ in their specific units of volume (the bushel, gallon, fluid ounce, etc.). a489ef542a
